House to implicate me and my family in false cases and cause us for monetary considerations. As such, he is a threat to the law abiding citizens. I have also produced a fake and forged bill of Rs. 476,000. from [redacted]

(Annexure B). A cursory look

at the bills itself will reveal their fake nature. Some of the things which are quite obvious are: a) The bill has not been signed and issued by any Individual b) The bill is not even a proper bill. It is an estimate of a function. c) The bill is a forged copy in which the visiting card has been superimposed upon a estimate form, and Xeroxed to create an impression of a bill d) The flow of money and the Instrument of payment (cash/cheque etc) to pay the bill has neither been mentioned nor corroborated 5. These Illegal and Immoral acts of [redacted] and her family members are a threat to any law abiding citizen of this country. Through this application, I request you to kindly investigate the false and forged bills produced by [redacted] These bills should also be subjected to forensic tests to establish their authenticity. An impartial and speedy Investigation into this matter will not only be in the interest of Justice, but also be a sign that the Police are there to protect the ordinary law abiding and honest citizens of this city.
