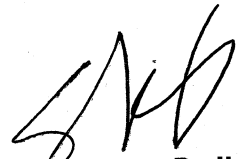
Order in the appeal under Section 19[1] of the RTI Act 2005

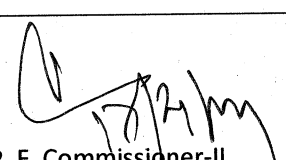
