My wife and her father have committed criminal breach of trust. They had come empty handed and stayed for around 1 hours and left with 8-10 bags full of items. I had immediately , till date i have got no response from Police . I started checking each and everything missing in my home . After checking we found that my wife and her father had taken all jewellery and other articles of my wife and even had stolen below mentioned gold items of me and my family members and cash of Rs. 2.5 lakhs, which was kept in my mother's almirah. List of items stolen by my wife and her father., are as under : . Cash amounting to 2.5 Lac INR . My Gold Kada . My Gold Chain . Gold Chain which belong to my mother. Gold chain and pendant set which belongs to my mother . My father's Gold Kada . My father's 2 gold rings . Watch set . My mother's 3 gold rings . My mother's 2 ear-ring sets. . Gold Bangle Set that belong to my mother (4 Bangles) . Diamond set which belong to my sister as she moved to Astralia and was kept at our home . Gold chain and pendant that belong to my sister . Gold Bangle and pendant that belong to my mother (4 Bangles) . Few gift that we received on reception, we had not even opened them . Clothes for kids (at least 10 set), which me sister brought from bangkok and were , kept in our home as my sister has moved to australia. My wife and her father have committed criminal breach of trust and stole all items as mentioned above.
